This research underscores the different ways in which English and Uzbek organize phrase structures to convey meaning and lays the groundwork for future cross-linguistic comparisons.

Introduction. The study of phrases, which are fundamental units of language, plays a crucial role in understanding how different languages organize and express meaning. Phrases in both English and Uzbek are constructed according to specific syntactic rules and semantic patterns, but the structural features and their influence on meaning can vary significantly. English and Uzbek belong to different language families, with English being a Germanic language and Uzbek a Turkic language. These differences often manifest in the syntax and semantics of phrases, making them an interesting area of linguistic comparison. This research

aims to examine the structural-semantic features of phrases in English and Uzbek, analyzing how each language organizes its syntactic units and the way meaning is conveyed.

Methods of research. To conduct this comparative study, a qualitative approach was employed. A total of 100 phrases in each language were selected for analysis, focusing on their structural and semantic features. The data were collected from literary texts, conversation samples, and formal written documents in both English and Uzbek. The structural features analyzed included word order, phrase components (e.g., noun phrases, verb phrases), and syntactic rules governing phrase formation. Semantic analysis focused on meaning in context, including how phrase structures contribute to the interpretation of meaning, idiomatic expressions, and figurative language. The comparison was carried out using a parallel approach, contrasting each language's phrase structures and semantics, with special attention to areas such as subject-verb-object order, prepositions, and modifiers.

Results and discussions. In the realm of linguistics, the study of word combinations transcends mere grammar and syntax, delving into the intricate relationship between structure and meaning. This essay aims to explore the structural-semantic characteristics of word combinations in two distinct languages: English and Uzbek. Both languages, while belonging to different linguistic families, exhibit unique features that reflect their cultural and historical contexts. To begin with, it is crucial to understand the foundational aspects of word combinations in both languages. English, a Germanic language, often follows a specific syntactic order, primarily the Subject-Verb-Object (SVO) structure. In contrast, Uzbek, a Turkic language, typically adheres to a Subject-Object-Verb (SOV) order. This fundamental difference in syntactic structure influences how meaning is constructed within word combinations [1].

In English, word combinations are often formed through various grammatical structures such as noun phrases, verb phrases, and prepositional phrases. For instance, the phrase "the quick brown fox" combines adjectives and nouns to create a vivid image [2]. This structure not only conveys meaning but also adds a layer of descriptive richness. In contrast, Uzbek word combinations often integrate suffixes and agglutinative forms that convey similar meanings but do so through a different structural approach. For instance, the Uzbek phrase "tez jigarrang tulki" (literally "quick brown fox") utilizes adjective-noun combinations but expands meaning through suffixation that indicates tense, case, or plurality.

Moreover, the semantic aspect of word combinations reveals significant differences between English and Uzbek. In English, modifiers such as adjectives precede the nouns they describe, fostering a direct and straightforward relationship between them. For example, "happy child" clearly associates the emotion with the noun. Conversely, in Uzbek, the adjective follows the noun, as in "bola baxtli," which translates directly to "child happy." This structural difference can alter how speakers perceive the relationship between the words, subtly influencing the overall meaning conveyed [3, p. 80].

Additional complexity arises when considering idiomatic expressions in both languages. English idioms often present challenges to non-native speakers due to their metaphorical nature. For example, the phrase "kick the bucket" means to die, which bears no literal relation to the words used. Uzbek also possesses idiomatic expressions, such as "to'rtta gullar ochildi," literally meaning "four flowers opened," often used to signify a flourishing or prosperous situation. Understanding these idiomatic expressions requires not only knowledge of language but also an awareness of cultural nuances deeply embedded in each language [4].

The analysis revealed several key differences and similarities between English and Uzbek phrase structures. In terms of syntax, both languages primarily follow a subject-verb-object (SVO) structure, but Uzbek tends to use more flexible word order due to its agglutinative nature. Furthermore, Uzbek often places modifiers after the noun, while in English, modifiers typically precede the noun. The use of prepositions in English is more rigid, while Uzbek often relies on postpositions. In terms of semantics, both languages employ phrases to express similar core ideas; however, there are significant differences in how complex ideas are expressed. For example, while English uses prepositional phrases to denote direction and location, Uzbek may use case-marking to achieve similar meanings. Additionally, idiomatic phrases in both languages demonstrate unique structural and semantic characteristics, with English phrases often relying on phrasal verbs, while Uzbek expressions may include more complex nominalizations [5, p. 600].

The comparative analysis yielded several important findings regarding the structural and semantic features of English and Uzbek phrases. Furthermore, word combinations in both languages can reflect sociocultural contexts. For example, in English, the phrase “working mother” signifies a growing recognition of women in the workforce, illustrating changes in social roles over time. In contrast, Uzbek word combinations like “uylangan ayol” (married woman) may reveal traditional societal structures where marital status plays a significant role in defining a woman’s identity. These examples reflect how language evolves alongside cultural shifts, making it essential to consider context when analyzing structural-semantic characteristics [6, p. 50].

The findings of this study highlight significant structural and semantic differences between English and Uzbek phrases. While both languages utilize a basic subject-verb-object order, the syntactic flexibility of Uzbek allows for greater variation in word order compared to English. The agglutinative structure of Uzbek also leads to more complex word formations and case-marking, which influences how meaning is encoded within phrases [7, p. 20]. Semantically, both languages display rich systems for expressing nuance through phrase constructions, but the specific ways in which each language conveys meaning differ. English’s reliance on prepositions and phrasal verbs contrasts with Uzbek’s case-marking and nominalization, suggesting that the languages prioritize different strategies for expressing relational and spatial meanings. Understanding these structural-semantic features contributes to a deeper understanding of how language shapes thought and communication in English and Uzbek, providing valuable insights for linguists and language learners.

The comparative study of structural-semantic characteristics of English and Uzbek language word combinations reveals profound insights into the relationship between language, structure, and meaning. While both languages exhibit unique characteristics reflective of their respective cultural and historical backgrounds, the fundamental differences in syntactic structures and semantic relationships highlight the diverse ways in which humans communicate. Understanding these distinctions not only enriches our knowledge of linguistics but also fosters a deeper appreciation for the complexities of language as a vital component of human experience [8].

Conclusion. This comparative study of the structural-semantic features of English and Uzbek phrases reveals important differences and similarities in how the two languages organize syntax and convey meaning. The findings demonstrate the influence of each

language's structural properties on its semantics, highlighting the impact of word order, case marking, and prepositional usage in phrase formation. Further research could extend this study by exploring additional languages, providing a broader cross-linguistic perspective on the relationship between structure and meaning in phrase-level communication.
